Friday Keynote Speaker: Behzad Noubary

Mr. Behzad Noubary has been serving as Deputy Representative of the United Nations Children's Fund (UNICEF) in Morocco since August 2016. Mr. Noubary joined UNICEF in 2008, with assignments in New York, Gabon, Democratic Republic of Congo, and Yemen. Prior to joining UNICEF, Mr. Noubary worked as management consultant at PricewaterhouseCoopers in the US and served in the Peace Corps in Burkina Faso. An American citizen of Iranian descent born in the UK, Mr. Noubary holds degrees from Bloomsburg University of Pennsylvania and Columbia University. In 1995, he received one of GASI's first Student Scholarships in support of his conference presentation in Shanghai, China. He currently resides in Morocco with his wife and daughter.



Saturday Keynote Speaker: Mia Jeong

Ms. Jeong is a child protection and humanitarian professional, with over 10 years of experience working in a broad range of capacities, including coordination, technical assistance, research, assessment, monitoring and evaluation, and project management. Since 2003, Ms. Jeong has worked for UN agencies and NGOs in Yemen, South Sudan, Democratic Republic of Congo, Chad, Central African Republic, Nepal, Cambodia, Lebanon and Morocco, and much of her work has involved working with conflict-affected populations. She has an in-depth knowledge and experiences in child protection, sexual and gender-based violence, humanitarian coordination, cash-based intervention and rapid response for displaced populations. Ms. Jeong holds two Master's degrees, one in Peace Studies from Graduate Institute of Peace Studies, Korea, and the other in Humanitarian Assistance from Catholic University of Louvain, Belgium.

GASI-UNIVERSITY COURSEWORK PARTNERSHIP MODEL

For the first time, **West Chester University** of Pennsylvania (WCU) has initiated a program linking course credit to GASI conference participation. Martinez, Assistant Director/Coordinator of Diversity Initiatives for West Chester University's Office for Diversity, Equity & Inclusion and GASI Past President, was instrumental in engaging students for the course and building the program.

Requirements for Submitting Papers for the GASI 2019 Conference Proceedings

1. Only papers presented at the 28th Annual Conference will be considered for publication in the *Conference Proceedings*. The editor reserves the right to select only those papers and to review them for appropriate content and format.
2. Papers must be submitted by **August 30, 2019**
3. Papers must be submitted by email to Dr. James C. Pomfret, Executive Director and *Proceedings Editor* with **GASI 2019 Proceedings** in the subject area.
4. Authors should keep length to approximately 12 pages.
5. Papers should be submitted as **MS Word files**. Papers may not be submitted as PDF files.
6. Pages should be formatted with 1” margins, right, left, top, and bottom.
7. Font should be 12 point Arial with 1.5 line spacing. Titles, headings, and subheadings should be in the same font.
8. Graphs, tables, and diagrams must properly formatted and be incorporated within the formatted text. **No title page should be included.**
9. **The title, author, author’s professional affiliation, and author’s email address should appear centered at the top of the first page.** The title should be written in Title Case, (also known as Headline Style or Up Style) which is defined by the rule, “Capitalize the first and last words of the title and all nouns, pronouns, adjectives, verbs, adverbs, and subordinating conjunctions (*if, because, as, that,* and so on)e.g. "Rules for Capitalizing the Words in a Title."
10. An abstract or key words list may be included at the author’s discretion.
